Featured Keynote Presented by Patrick Friman, PhD

Colloquial Descriptions of Behavior Analytic Treatment Concepts: Multiple Examples

There is much to love about behavioral analysis but the perfect love is hard to find, especially in the sciences. An obstacle to love is imperfect, incomplete, or incomprehensible communication. And because the technical language of behavior analysis is so challenging, even for those inside the field, using it with people outside the field can limit or completely preclude their capacity for loving (or even just liking) the science. This talk will present a variety of behavior analytic treatment concepts and use plain every language to describe them.

A1/A5) It Took a Village

Presented by Heidi Arva and Gwen & Gene Harshaw

This session qualifies for ACT 62 BSL training hours (1.5 hours of Family Collaboration).

Parents/caregivers/guardians are under a great deal of stress when raising a child with special needs. Hear one family's story of raising an autistic child into adulthood. The old African adage states it takes a village to raise a child. A reflection of this journey reveals how large the village population swelled. You will understand how his family and his village used their gifts and talents to help bring about the springing forth of his own gifts and talents.

A2/A6) Understanding Wellness

Presented by Greg Cherpes, M.D.

This session qualifies for ACT 62 BSL training hours (1.5 hours of Autism-Specific Training).

The pursuit of wellness enhances our lives. Wellness is more than the absence of illness. Wellness involves an active process of growth and change. This session intended for a general audience will review the areas of wellness and the importance that they play across the lifespan. Building from an understanding of these areas, barriers that individuals with autism spectrum disorder may face and tools for pursuing wellness will be discussed.

A3/A7) Navigating the Complexities of Meaningful and Functional Communication for Individuals with Autism

Presented by Amy Alford & Krista Lewis

This session qualifies for ACT 62 BSL training hours (0.75 hours of Instructional Strategies & Best Practices plus 0.75 hours of Skill Deficits).

In a communication-requisite world, we have a responsibility to ensure all people can communicate in a meaningful and functional way. It is not enough to rely on verbal language, nor is it sustainable to simply 'know' what a person with autism wants or needs. Communication is complicated, but across systems and disciplines, we have learned a variety of methods to understand this topic and population. This training will explore the definition of communication through multi-disciplinary perspectives, explain why it is important to accurately identify how an individual with autism expressively and receptively communicates, and provide tools, resources, and strategies to support individuals with a variety of communication needs.

A4/A8) Suicide Prevention and Intervention for Youth with Autism Spectrum Disorder

Presented by Dr. Perri Rosen and Amy Kabiru

This session qualifies for ACT 62 BSL training hours (1.5 hours of Co-Morbidity and Medication).

There is limited research on prevalence and risk factors of suicidality among youth with autism spectrum disorders, as well as on best practices to suicide risk assessment and intervention with this population. This presentation will synthesize existing research and identify gaps in the literature, as well as provide practical recommendations for mental health professionals serving youth with ASD.

B1) Autism in the Criminal Justice System

Presented by Kate Hooven and Jesse Torisky, Eastern ASERT

This session qualifies for ACT 62 BSL training hours (3 hours of Autism-Specific Training).

The attendees will obtain an overview of the criminal justice process and the ramifications of an arrest, how they can/should interact with law enforcement, probation officers, and attorneys, and what to do if their client is arrested, has to stand trial, and even be incarcerated.

Attendees will discover various resources such as social stories that will help them prepare for an interaction with law enforcement. Attendees will have a better understanding of how they can help individuals with autism PLAN (Prepare, Learn, Advise and Notify) for a positive interaction in the criminal justice system.

B2) Be Safe and Be Social: Helping Individuals with ASD Build Healthy Relationships

Presented by Michael Murray, M.D. and Andrea Layton, Central ASERT

This session qualifies for ACT 62 BSL training hours (1.5 hours of Instructional Strategies & Best Practices plus 1.5 hour of Skill Deficits).

The majority of individuals with ASD, especially adolescents and adults, consistently report dissatisfaction with their social lives. Individuals with ASD who also present with complex communication needs have even greater difficulty finding meaningful community engagement and are particularly vulnerable to victimization. In this interactive workshop, participants will gain increased insights and the tools needed to help individuals with ASD achieve their relationship goals. Emphasis will be placed on helping individuals with ASD increase safety while increasing their social interactions. Case examples will illustrate key concepts and participants will be encouraged to interact throughout the presentation to assess their own understanding.

B3) Meeting the Complex Needs of Individuals with Dual Diagnosis through a Multidisciplinary Approach

Presented by Ryan Cramer and Heather Capo, Western ASERT

This session qualifies for ACT 62 BSL training hours (3 hours of Co-Morbidity and Medication).

In order to meet the complex needs of individuals with dual diagnosis it is imperative that all aspects of the root causes of these complexities are understood and addressed. Many individuals with dual diagnosis can present with needs that may require assessment and treatment by a variety of disciplines in order to mitigate challenges. During this workshop presenters will discuss and describe an integrated

approach to assessment and treatment for individuals with multiple and complex needs including psychiatric, behavioral and physical health domains.

Life in the Community Like Everyone Else: Fundamentals of Community Inclusion

This session qualifies for ACT 62 BSL training hours (2 hours of Autism-Specific Training).

This session will describe community participation and inclusion and its importance for health and wellness and then offer the fundamentals for promoting full inclusion. Specific fundamentals that will be emphasized include beliefs about the capabilities of people with autism to participate, promotion of choice and dignity of risk, addressing a full range of participation domains, recognizing the critical role of family and significant others in the promotion of inclusion, and addressing environmental barriers based on the social model of disability.

CONTINUING EDUCATION FOR PROFESSIONALS

All requests for continuing education will be made onsite at the conference by turning in the completed *PATC 2019 Attendance Verification* form before leaving the event. A professional number or license number is required for BCBA, NBCC, and Social Work CEU applicants; this number must be included on the form, so be sure to have your number on hand at the conference.

CERTIFIED BEHAVIOR ANALYSTS: The Bureau of Autism Services is approved by the Behavior Analyst Certification Board (BACB) to offer continuing education for certified behavior analysts. This program is being offered for up to 2.5 continuing education credits. BAS maintains responsibility for the program(s). BCBA credits are only available to individuals who are board certified behavior analysts for the specific sessions noted.

SOCIAL WORK (LSW/LCSW, LPC, LMFT): This program is offered for up to 11 hours of social work continuing education through the Bureau of Autism Services, a PA pre-approved provider of social work continuing education. Each contact hour is equal to 1 continuing education credit. These credit hours satisfy requirements for LSW/LCSW, LPC and LMFT biennial license renewal. BAS maintains responsibility for the program(s).

COUNSELORS: The Bureau of Autism Services is an NBCC-Approved Continuing Education Provider (ACEP) and may offer NBCC-approved clock hours for programs that meet NBCC requirements.
