

# Open For Public Comment: Proposed Transportation Trip Fee Schedule Rates in the Adult Autism Waiver ODP Announcement 19-157

### AUDIENCE:

Individuals and Families, Providers of Transportation Trip services in the Adult Autism Waiver, Supports Coordination Organizations, Other Interested Parties

#### **PURPOSE:**

The purpose of this communication is to announce the publication of the Department of Human Services (Department) proposed Fee Schedule Rates for Transportation Trip services that will be added to the Adult Autism Waiver effective January 1, 2020. Public comment on these proposed changes will be accepted until 11:59 pm on January 7, 2020.

#### **DISCUSSION:**

Effective January 1, 2020, the Department proposes to add Transportation Trip as a service available in the Adult Autism Waiver. The amendment to the Adult Autism Waiver that contains this change is currently with the Centers for Medicare and Medicaid Services (CMS) for approval. In anticipation of approval, a public notice was published in the *Pennsylvania Bulletin* Volume 49, Number 49 on Saturday, December 7, 2019. The notice informs stakeholders of the proposed Fee Schedule Rates for Transportation Trip services that will be funded through Adult Autism Waiver.
