

# PERIODIC RISK EVALUATION (PRE): INDIVIDUAL SUPPORT PLAN (ISP)

The PRE is designed to inform the ISP. This service guidance document shows how the PRE informs different sections of the ISP. Note the different domains and how to document applicable information in the ISP.



RISK DOMAIN	ISP SECTION
Law Enforcement	General Health and Safety Risks; Psychosocial Information; Crisis Support Plan
Risk of Harm to Self or Others	General Health and Safety Risks; Psychosocial Information; Behavioral Support Plan; Crisis Support Plan
Unstable Living Environment	General Health and Safety Risks; Social/Emotional; Crisis Support Plan;
Natural Supports	General Health and Safety Risks; Know & Do; Crisis Support Plan
Substance Use	General Health and Safety Risks; Psychosocial Information; Behavioral Support Plan; Crisis Support Plan; Other Non-Medical Evaluation
Chronic Medical Conditions	General Health and Safety Risks; Medications/Supplements (and Treatments); Physical Assessment (System Area and Description) ; Current Health Status
Stressful Life Events	General Health and Safety Risks; Social/Emotional; Crisis Support Plan
Co-Occurring Mental Health Diagnoses	General Health and Safety Risks; Psychosocial Information; Behavioral Support Plan; Health Promotion; Crisis Support Plan; Other Non-Medical Evaluation

## NOTES:

**\*\*DISCLAIMER: All identified risks should be documented in the ISP under Health and Safety > General Health and Safety Risks. This section should include a brief summary of the risks and the plan to mitigate those risks.\*\***

- Document in other ISP sections as appropriate. For example, if a trauma evaluation was conducted it would be appropriate to summarize in “Other Non-Medication Evaluations”. Information in the Psychosocial Section reflects what has happened in the past 12 months. Social/Emotional is used to document information that is historical – more than 12 months in the past.
- An updated FBA, revisions to the Behavioral Support Plan and revisions to the Crisis Intervention Plan may be warranted based on the information gleaned from the PRE.

The PRE was developed to assess risk level of adults with autism over the age of 21 who are served by programs overseen by Pennsylvania’s Department of Human Services, Office of Developmental Programs, Bureau of Supports for Autism and Special Populations (BSASP) and may not accurately assess risk levels of other individuals with autism. If the PRE is used to assess risk levels of other individuals with autism, the results may not be able to be interpreted or be used to inform clinical treatment delivery. Additionally, the PRE captures historical information and should not be used as a definitive predictive tool for future behavior and risk domain experiences.
